Terms of Service

Welcome to the Promethium (“**Promethium**”) Sandbox website located at [URL] (the “**Site**”). Please read these Terms of Service (the “**Terms**”) carefully because they govern your use of our Site and our Sandbox services accessible via our Site. To make these Terms easier to read, the Site, our services and App are collectively called the “**Services.**”

- 1. Agreement to Terms.** By using our Services, you agree to be bound by these Terms. If you don’t agree to be bound by these Terms, do not use the Services. If you are accessing and using the Services on behalf of a company (such as your employer) or other legal entity, you represent and warrant that you have the authority to bind that company or other legal entity to these Terms. In that case, “you” and “your” will refer to that company or other legal entity.

You may not assign or transfer these Terms, by operation of law or otherwise, without Promethium's prior written consent. Any attempt by you to assign or transfer these Terms, without such consent, will be null. Promethium may freely assign or transfer these Terms without restriction. Subject to the foregoing, these Terms will bind and inure to the benefit of the parties, their successors and permitted assigns.

For notices made by e-mail, the date of receipt will be deemed the date on which such notice is transmitted.
